# MINUTES OF THE 26<sup>th</sup> ANNUAL GENERAL MEETING OF THE TRADE FINANCE ASSOCIATION OF BANKERS

The 26<sup>th</sup> Annual General Meeting of the Trade Finance Association of Bankers was held on Thursday 23<sup>rd</sup> February 2023 at 5.30 p.m. at the 'Lotus Room', Grand Oriental Hotel, York Street, Colombo 01.

#### ITEM NO 01 - Reading of the notice convening the meeting

The Secretary General read out the notice convening the meeting at the request of the President.

#### ITEM NO 02 - Welcome Address by the President

The President Mr. Lawrian Somanader addressed the gathering by warmly welcoming the members to the 26<sup>th</sup> Annual General Meeting of the Association.

The President in his speech pointed out the role played by the TFAB to the banking industry during its last 25 years of existence and celebrating 25<sup>th</sup> Anniversary Celebration with prevailing economic condition in the country. It is envisaged that the TFAB will continue to play its pivotal role of developing people by enhancing the knowledge and sharpening the skills of Trade practitioners involved in Import and Export business.

Further, he pointed out that the Association along with its members had challenging times during the last few years.

- 2022 was marked by major economic and political upheaval making the year and unprecedented one.
- For the first time in the Sri Lanka announced that it would halt repayment of its foreign debts.
- This resulted in down grading of the countries credit rating which blocked FCY borrowings.
- The inflation hit an all time high of 73% in Sep. 2022

The President highlighted the main events conducted by TFAB during 22/23 as Interbank Cricket Sixes, Multi Religious Ceremony, Port Tour, Quiz and Social and he thanked all the past presidents, members of the advisory committee, all council members and the members of TFAB for the support extended during his tenure as president. He concluded the address by pledging his commitment towards the betterment of TFAB.

# ITEM NO 02 – Reading of the notice convening the meeting

The Secretary General read out the notice convening the meeting at the request of the President.

# ITEM NO 03 - Adoption of Minutes of the 25<sup>th</sup> Annual General Meeting held on 09<sup>th</sup> March 2022

The minutes of the 25<sup>th</sup> Annual General Meeting held on 09<sup>th</sup> March 2022, at the Grand Oriental Hotel, York Street, Colombo 01, were presented and approved. The adoption was proposed by Mr. K. K. Susantha and seconded by Mr. Harsha De Silva.

# ITEM NO 04 - Presenting of the Annual Report of the Association submitted by the Secretary General

The Annual Report of the Association for the period March 2022 to February 2023 was presented to the house by the Secretary General.

# ITEM NO 05 – Adoption of the Audited statement of Accounts of the Association for the period 01 January 2022 to 31 December 2022

The audited accounts of the Association for the period 01<sup>st</sup> January 2022 to 31<sup>st</sup> December 2022 were tabled for approval.

Mr. Gaya Manamperi pointed out that, Interest flow from Development Fund to Special Account were not indicated on accounts as per the constitution. Mr. President and Treasurer agreed to correct it and circulate among the members.

Adoption of Annual Accounts was proposed by Ms. Halin Hettigoda and seconded by Mr. W Kumarasiri.

# ITEM NO 06 – Adoption of any resolutions, notice of which has been received in writing by the Secretary General on or before 16<sup>th</sup> February 2023.

Amendment to the constitution proposed by the present council (2022/2023) to insert nomination committee to elect office-bearers and council members to the council with effect from 2024.

If no valid nominations have been received for any Office Bearer/s or Council Member/s such Member/s shall be elected at the AGM Delete sub-paragraph 09.04 "Perform all such duties that may be assigned by the Council from time to time" completely and insert sub-paragraph 09.05 under paragraph 09.00 09.05 Perform all such duties that may be assigned by the Council from time

Mr. Gaya Manamperi requested to explain on composition of Nomination committee and not to include any council member to the committee as APB's practice. Then, The President stated that we have already referred several constitutions including APB and come up with this amendment and composition of the Committee will be finalized at the council meeting.

Members of the AGM unanimously approved the proposal.

#### ITEM NO 07 - Election of Office Bearers, Council members and Auditor

Before vacating the chair Mr. Lawrian Somanader has requested the house to propose the Pro-tem Chairman. Mr. W Kumarasiri proposed Mr. Thushy David to be the Pro-tem Chairman to conduct the proceedings relating to the election of the President for the ensuing year. It was seconded by Mr. Gaya Manamperi.

Mr. Thushy David thanked the house for electing him as Pro-tem Chairman. During his short speech he thanked Mr.Michael Peiris for conducting the AGM as a Pro-tem Chairman over the years and due to his absence agreed to serve as the Pro-tem Chairman. Mr.Thushy David also thanked Mr. Lawrian Somanader for the contribution he made for the association as the president and also briefed the house about the proceedings pertaining to selection of office bearers & council members. He then called upon the house to elect the President for the ensuing year.

The Name of Mrs. Rochell Fernando was proposed by Mr. K. K. Susantha and Seconded by Mr. Gaya Manamperi. Since there were no other names proposed, Mrs. Rochell Fernando was duly elected as the President for the ensuing year.
